**REFRESHMENTS/ORIENTATION:** Sunday, February 21, 2010 at 2:00 p.m., in the Free State Building located on the Van Zandt County Fairgrounds. A photographer will be set up to take a head shot of your child for the program at no charge. A group picture will be taken for the newspaper.

## REHEARSAL:

Monday, March 22, 2010 at 6:00 p.m., in the Todd Berry Building located on the Van Zandt County Fairgrounds. A parent or guardian **MUST** be at the practice. If you are not able to attend, please call and let one of us know.

## PAGEANT:

Saturday, March 27, 2010 at 9:45 a.m. All finalists in each age group **MUST** return Saturday evening March 27, 2010 at 5:30 p.m., for crowning. If finalist does not return for crowning they will forfeit their title and it will be awarded to the next eligible contestant.

## PARADE:

Winners will be required to participate in any upcoming parades.

**PHOTOGENIC:** This is an optional category your child may enter. The additional amount to enter this category is \$15.00. They will be judged by the Pageant Judges. Please submit a recent 5X7 photo, taken within the last 3 months of due date, which is Monday, March 22<sup>nd</sup> at rehearsal.

**PHOTOGRAPHER:**

There will be a photographer available the night of the pageant in the building taking pictures, if you are interested in purchasing photographs.
